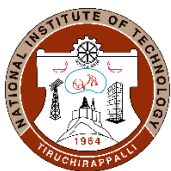
COURSE OVERVIEW

4. The concepts of gradient, curl, divergence and associated theorems.



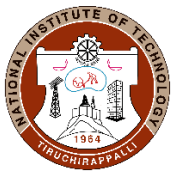
